

CONSORTIUM LICENSE AGREEMENT FOR ONLINE ACCESS TO
AMERICAN MEDICAL ASSOCIATION PUBLICATIONS

This Agreement is made effective January 1st, 2017 ("Effective Date") by and between the American Medical Association ("AMA") located and doing business at 330 North Wabash, Chicago, IL 60611 and the University of Alberta and the University of Calgary as represented by the Health Knowledge Network, a consortium working on behalf of its consortium members located in Alberta, Saskatchewan and Manitoba.

DEFINITIONS

1. "Institutions" means those institution(s) identified on Exhibit B that are members of the Consortium and to whom the Consortium will grant a sublicense hereunder for online access to the Licensed Materials solely for the purpose set forth herein.
2. "Authorized Users" means the (i) Institutions identified in Exhibit B; and (ii) individuals who are authorized by the Institutions in Exhibit B to access the Institution's Secured Network due to their status as current medical staff, students, faculty members, employees, independent contractors, or walk-in/onsite visitors.
3. "Licensed Materials" means those AMA publications identified on Exhibit A that the Consortium licenses hereunder with the right to sublicense to the Institution(s).
4. "Secured Network" means a network (whether a stand alone network or a virtual network within the Internet) for which a username and password is required and which is maintained or controlled by each respective Institution
5. "Term" means the Initial Term and Renewal Term(s), if any.
6. "Territory" means the country of the Consortium and each respective Institution.

AGREEMENT

NOW THEREFORE, in consideration of the mutual covenants and promises contained herein, the parties agree as follows:

1. Grant of License:

(a) Subject to the terms and conditions of this Agreement, AMA grants to Institution, as represented by the Consortium, a non-exclusive, non-transferable right to permit Authorized Users wherever located to access the Licensed Materials on-line via a Secured Network for the purposes of research, teaching, private study, and administrative use associated with the normal practices and activities of the Institution(s) and its Authorized Users.

(b) Subject to the terms and conditions of this Agreement, Consortium may sublicense to each Institution the right to access the Licensed Materials on-line via the Institution's Secure Network as described in Section 1(a) and solely for the purposes permitted

in Section 2, provided that Consortium acknowledges and agrees that any breach of any term of this Agreement by any Institution or other Authorized User shall be deemed a breach by Consortium. Consortium shall use best efforts to ensure that access and use of the Content is limited to Authorized Users and that all Authorized Users are notified of and comply with the usage restrictions set forth in these Terms and Conditions.

(c) Neither Consortium nor any of the Institutions shall make the Licensed Materials available or accessible outside the Secure Network, administered and located in Canada. In the event that AMA advises Consortium that access to the Licensed Materials in any country or region within the Territory may be prohibited by law or may, in AMA's judgment, restrict or limit AMA's ability to preserve or enforce its copyrights in or to any Licensed Materials, AMA shall have the right to immediately restrict access to and availability of the Licensed Materials in that country or region.

2. Permitted Uses of the Licensed Materials

During the Term of this Agreement, Authorized Users shall access and use the Licensed Materials solely for the non-commercial purposes of research, teaching, patient care and/or private study. In furtherance of the foregoing, Authorized Users may:

(a) Search, view, retrieve and display content and data contained in the Licensed Materials.

(b) Print out a single copy of an article, or discrete items or portions of an article (e.g., graph, table) from searches of the Licensed Materials.

(c) Download or store a copy of an article, or discrete items or portions of an article (e.g., graph, table) from searches of the Licensed Materials for individual archival purposes only.

(d) Transmit a single electronic copy of individual articles, or discrete items or portions of such articles (e.g., graph, table) from searches of the Licensed Materials, to another Authorized User for use in accordance with this Agreement.

(e) Distribute a single printed copy of individual articles, or discrete items or portions of such articles (e.g., graph, table) from searches of the Licensed Materials, to another Authorized User for use in accordance with this Agreement.

(f) Each Institution may (i) incorporate (without modification or amendment) individual articles from the Licensed Materials into electronic course packs, provided that the Institution shall delete all copies of any Licensed Materials retained in electronic course packs when no longer used for such purpose and in no event shall such Licensed Materials be retained for longer than one academic year; and (ii) loan or supply to another library within the same Territory (e.g., same country) as the Institution, a copy of an individual document being part of the Licensed Materials by mail, fax or secure electronic transmission via the Internet or otherwise, for the purposes of research or private study and not for commercial use, provided that the Institution complies with applicable copyright law, including Fair Dealing provisions.

3. Prohibited Uses of the Licensed Materials

Any and all commercial use, distribution, or transmission of the Licensed Materials is strictly prohibited. In addition, Authorized Users shall not:

(a) Access or use the Licensed Materials on any public computer-based information system, including without limitation, any electronic bulletin board available to the public, the internet or the world wide web; provided, however, that nothing contained herein shall prohibit Authorized Users from accessing or using the Licensed Materials on publicly available computer systems so long as such access or use is made through the Secured Network.

(b) Make copies of the Licensed Materials except as permitted in Section 2.

(c) Except as specifically permitted in this Agreement, transfer, sublicense, display, perform, release, distribute, or sell the Licensed Materials.

(d) Prepare derivative works or incorporate the Licensed Materials, in whole or in part, in any other work or system except as permitted pursuant to Section 4 of this Agreement.

(e) Reverse engineer, decompile or modify the Licensed Materials, in whole or in part.

(f) Use or authorize use of the Licensed Materials in any database or other compilation (except for electronic course packs if Licensee is an academic institution).

(g) Create a database or compilation containing the Licensed Materials, or otherwise store any Licensed Materials in any retrieval system (except for electronic course packs if an Authorized User is an academic institution).

(h) Use any robot, spider, or other automatic device, to monitor, upload, download or copy, including any systematic downloading or copying of, the Licensed Materials in whole or in part.

(i) Allow use or access to the Licensed Materials by anyone who is not an Authorized User.

(j) Modify, remove, cover, obscure, block or change any disclaimers, or copyright, trademark, and other intellectual property rights notices, which may appear on or in association with print or electronic copies of the Licensed Materials.

4. Reproduction or Republication of the Licensed Materials

Authorized Users must obtain AMA's permission to incorporate any Licensed Materials into a printed course pack or for any other reproduction or republication not permitted in Section 2 or by the legal doctrine of "fair use" under United States or similar international copyright law.
